Developing the national status of the "health" of our observing systems



Summarizing the need: A <u>nationally consistent</u> infrastructure inventory and rating methodology that:

(1) Articulates the system we are striving for:

- (a) Mission areas / requirements currently served and what that system *should* look like
- (b) Mission areas / requirements NOT met and what that system should look like

(2) Identifies the associated costs of:

- (a) Sustaining current system health, addressing risks, and filling gaps
- (b) A growth and evolution plan for unfunded requirements
- (c) Provides a national framework that allows for regional priorities in implementation

Consolidated Unfunded Requirements List

The CURL is our earlier attempt at this task

- Put together quickly right before BIL (2021) to advocate for infrastructure needs as well as non-infrastructure support needed for those infrastructure needs
- Needs updating → i.e., what was funded under BIL, IRA, or annual appropriations since 2021?
 - What remains as an unfunded requirement?
 - Are there new unfunded requirements to add?
 - Refine format / information guidance to get better answers
- Needs to be a living document
- Define "unfunded requirement"
 - Regional level:
 - Unfunded projects from 5-Year Cooperative Agreements that are still relevant
 - New needs identified through stakeholder engagement
 - National level:
 - Legislative mandates
 - Political drivers / opportunities
 - U.S. IOOS Office priorities



A living, annually updated Recapitalization Plan

Build on the CURL and account for:

- Annually updated unfunded requirements
- Regular annual infrastructure recapitalization need based on schedule of system lifespans, etc.
- Sustaining existing infrastructure:
 - To include planning for sustaining new IRA efforts after "cliff"
- System modernization & evolution to meet
 - Unfunded requirements
 - Emerging national priorities with regional expressions (e.g., OSW, mCDR)
 - Equitable service delivery

Considerations:

- How do we craft the framework for needed national consistency (i.e., a high level system plan) that allows for regional priorities and differences?
- How does it relate to reporting at regional level?

Next steps:

- Agreement from RA Directors → August
- Discuss approach / process → September IOOS Fall meeting


President's **Budget**
